1. INTRODUCTION

2. PURPOSE

The purpose of this solution is to provide maintenance of the existing sewage system at Emfundisweni Skills Centre.

3. BACKGROUND

Alfred Nzo Development Agency is an Agency that is wholly owned by the Alfred Nzo District Municipality. One of the responsibilities given to the Agency by the principal is to acquire, own and manage land and buildings on behalf of the Alfred Nzo District Municipality.

Emfundisweni Skills Development and Resources Centre is one of the properties that were transferred through the TFC process. Alfred Nzo Development Agency has a responsibility to maintain and manage all the properties that were transferred from the OR Tambo District Municipality to Alfred Nzo District Municipality after the new demarcation process. The Agency has been maintaining and supporting the center since the transfer of the property.

Emfundisweni Skills Development Centre has signed an SLA document with Alfred Nzo Development Agency for Support, managing and maintenance of the Centre including payment of electricity costs from the Admin Building.

- Cleaning and unblocking of sewer pipes and 13 drains 110mm-160mm
- Construction of an additional 3 manholes laying of 100m pipe
- Laying of 100m pipe

- Removal of sludge
- Recasting
- Replacement of lids 450mm*600mm (material included in different section
- Excavation and removal of existing +- 100mm sewer pipe and preparation for manhole construction
